| Entrance counseling  | Email sent to students regarding entrance counseling; where to go, how to complete, and where they can go to find more information regarding their loans | <p><b>Example of Email sent to students</b></p> <p><b>“Entrance and MPN:</b></p> <p>Your Transylvania Financial Aid award letter includes Subsidized and/or Unsubsidized Federal Direct Student Loans. In order for these funds to be applied to your student account, please complete the following as soon as possible:</p> <ol style="list-style-type: none"> <li>1. Entrance Counseling: Federal regulations require that you receive information about your rights and responsibilities as a student loan borrower. Go to <a href="http://www.studentLoans.gov">www.studentLoans.gov</a> , log in, and choose Complete Counseling to begin.</li> <li>2. Master Promissory Note (MPN): The MPN is a legally binding agreement stating that you promise to repay the loan with interest. Also at <a href="http://www.studentLoans.gov">www.studentLoans.gov</a> , log in and choose Complete a Master Promissory Note.</li> </ol> <p>As of May 10, 2015, you need an FSA ID instead of a PIN to log in to all Federal Student Aid websites. If you have not yet created your FSA ID, you can do so at <a href="http://www.studentLoans.gov">www.studentLoans.gov</a> . You will be given the option to link your Federal PIN to your FSA ID during the setup process. If possible, you should link your PIN so that you can begin using your FSA ID right away. If you are not able to link you PIN, you may have to wait 1-3 days after creating your FSA ID to complete the steps above.</p> <p>As you complete these steps, the Financial Aid Office will be notified and we will be able to</p> |

| Exit counseling | Accounting Office sends emails regarding exit counseling and also gives graduating and withdrawing students a packet of information regarding exit counseling and loan repayment and all information regarding their loans. Packets are mailed to students if not picked up. | <p><b>Exit Counseling Example</b><br/> “Dear Class of 2016,</p> <p>Congratulations on your upcoming graduation in May. While attending Transylvania you borrowed from the student loan program, therefore it is <b>mandatory</b> that you complete online Senior Loan Counseling. Those who have not completed by <b>May 5<sup>th</sup></b> will have a <b>hold</b> placed on their <b>diploma</b>. Please complete the following tasks by <b>as soon as possible</b>:</p> <ol style="list-style-type: none"> <li>1. Federal Perkins Loan counseling website: <a href="http://www.heartlandecsi.com/">http://www.heartlandecsi.com/</a>. Transylvania University uses ECSI for all Perkins loans processing and billing.</li> <li>2. Federal Direct Loan counseling website: <a href="https://studentloans.gov/myDirectLoan/index.action">https://studentloans.gov/myDirectLoan/index.action</a>. Click Sign In button, sign in, then click Complete Counseling, <b>Exit Counseling</b> to complete your session.</li> <li>3. Elect to receive your 1098T electronically via <a href="#">TNet</a>. Please log in and select the 1098T Electronic Consent.</li> <li>4. Updated email address with Transylvania at <a href="http://www.transy.edu/alumni/tnet_form.htm">http://www.transy.edu/alumni/tnet_form.htm</a>. This will ensure you are able to reset your password for TNet if you were to forget it. | Code of Conduct      | All Transylvania University financial aid officers adhere to this code of conduct   | <p>The Higher Education Opportunity Act conditions the eligibility of educational institutions to participate in Title IV programs on the development of and compliance with a code of conduct prohibiting conflicts of interest for its financial aid personnel [HEOA § 487(a)(25)]. Transylvania University officers, employees and agents are required to comply with this code of conduct. The following specific provisions bring Transylvania University into compliance with the federal law [HEOA § 487(e)].</p> <ol style="list-style-type: none"> <li>1. Neither Transylvania as an institution nor any individual officer, employee or agent shall enter into any revenue-sharing arrangements with any lender.</li> <li>2. No officer or employee of Transylvania who is employed in the financial aid office or who otherwise has responsibilities with respect to education loans, or agent who has responsibilities with respect to education loans, or any of their family members, shall solicit or accept any gift from a lender, guarantor, or servicer of education loans. For purposes of this prohibition, the term "gift" means any gratuity, favor, discount, entertainment, hospitality, loan, or other item having a monetary value of more than a de minimus amount.</li> <li>3. An officer or employee of Transylvania who is employed in the financial aid office or who otherwise has responsibilities with respect to education loans, or an agent who has responsibilities with respect to education loans, shall not accept from any lender or affiliate of any lender any fee, payment, or other financial benefit (including the opportunity to purchase stock) as compensation for any type of consulting arrangement or other contract to provide services to a lender or on behalf of a lender relating to education loans.</li> </ol> |

Transylvania shall not:</p> <ul style="list-style-type: none"> <li>a) for any first-time borrower, assign, through award packaging or other methods, the borrower's loan to a particular lender; or</li> <li>b) refuse to certify, or delay certification of, any loan based on the borrower's selection of a particular lender or guaranty agency.</li> </ul> <p>5. Transylvania shall not request or accept from any lender any offer of funds to be used for private education loans, including funds for an opportunity pool loan, to students in exchange for the institution providing concessions or promises regarding providing the lender with:</p> <ul style="list-style-type: none"> <li>a) a specified number of loans made, insured, or guaranteed under Title IV;</li> <li>b) a specified loan volume of such loans; or</li> <li>c) a preferred lender arrangement for such loans.</li> </ul> <p>6. Transylvania shall not request or accept from any lender any assistance with call center staffing or financial aid office staffing.</p> <p>7. Any employee who is employed in the financial aid office, or who otherwise has responsibilities with respect to education loans or other student financial aid, and who serves on an advisory board, commission, or group established by a lender, guarantor, or group of lenders or guarantors, shall be prohibited from receiving anything of value from the lender, guarantor, or group of lenders or guarantors, except that the employee may be reimbursed for reasonable expenses incurred in serving on such advisory board, commission, or group.</p> |
